

## Special terms and conditions on issuing and using Diners Club Standard card issued by Erste Card Club d.o.o.

1. These Special terms and conditions on issuing and using Diners Club Standard card Issued by Erste Card Club d.o.o. (hereinafter: Special terms) set special terms and conditions and fees for issuing and using Diners Club Standard card (hereinafter: DC Standard card).
2. Terms with a capital initial letter have the meaning as defined under the General terms of the Blanket Agreement on issuing and using the Diners Club card issued by Erste Card Club d.o.o. (hereinafter: General terms), unless otherwise specified in these Special terms.
3. DC Standard card is issued to Basic private and senior users, Additional private and senior users, student users and Business users.
4. If the DC Standard card is issued to winners in giveaways or prize contests, the Card is issued only to Basic private users. Spending limit on the Card of the users will be set to the amount of the won prize, and it will only be used for one-time purchases and contactless payments and will be valid until the expiry date indicated on the card. The Card cannot be used to withdraw cash, purchase in instalments, or arrange direct debit and does not participate in the award programme related to DC Standard card. In some cases, it is possible to limit card usage only to certain points of sale, depending on the award programme rules.
5. If Diners Club Standard card is issued to employees of business entities or members of associations with which Erste Card Club (hereinafter: ECC) has concluded an agreement on such business cooperation, card can have preferential terms of usage during the employment of the User with that business entity or membership in the association. In that case, in order to use and update the preferential terms, ECC will periodically check the employment status of the business entity or the status of membership in the association, which is the basis for the use of preferential terms. The User is obliged to notify ECC without delay of the termination of membership in the association, change of employment or retirement, and submit a new income statement.
6. Users to whom DC Standard card was given as replacement for Diners Club ORYX card (hereinafter: DC ORYX card) and Diners Club HAK card (hereinafter: DC HAK card) which expired, will be able to use ORYX Assistance package – Road Assistance PREMIUM in Croatia and abroad for Basic, Additional and Business users and the Home Assistance package for Basic and Additional users.

If the User does not agree with this, it is necessary to explicitly inform ECC not to activate the services, at least 15 days before the expiry of DC ORYX and DC HAK cards.

This service will be available to users of previous DC HAK and DC ORYX cards free of charge for the first year of use.

7. ECC, independently and/or in cooperation with other contractual partners, provides the following additional benefits to the DC Standard Card users:
  - Basic and Additional user: participation in the D Club award programme, in accordance with the Rules of the D Club award programme available on the website [www.erstecardclub.hr](http://www.erstecardclub.hr);
  - Business users: travel insurance in cooperation with Wiener insurance Vienna Insurance Group d.d. (hereinafter: Insurer), in accordance with the General terms for acquiring and exercising the right to insurance under Diners Club cards (hereinafter: General terms for insurance) and the special conditions of each type of insurance defined by the Insurer, available on the website [www.erstecardclub.hr](http://www.erstecardclub.hr).
  - Basic, Additional and Business users:
    - use of Airport Lounge lounge services in accordance with the Special terms of use of the Airport Lounge for Diners Club card users available on the website [www.erstecardclub.hr](http://www.erstecardclub.hr);
    - the right to insurance against an accident (with the User's special consent) in cooperation with the Insurer in accordance with the General terms and conditions for insurance and the special conditions of each type of insurance defined by the Insurer, available on the website [www.erstecardclub.hr](http://www.erstecardclub.hr).
8. The ECC will forward User's personal data to ECC's contractual partners for the purposes of exercising contracted benefits from article 7 of these Special terms.

9. These Special terms form an integral part of the Blanket Agreement on the issuance and use of the Diners Club Standard card. The General terms and conditions apply to everything that is not otherwise regulated by these Special terms and conditions

10. These Special terms and conditions enter into force on 1.8.2022. and replace the Special terms and conditions PU-DCST/06-2021/01 of 30.8.2021.
